- 1. President Jay Beltz called the meeting to order at 7:05pm. In attendance were Lolitia Bache, Tom Bache, Nick Bernal, Tonie Campbell, Milena Glusac, Paul Greer, Adam Henderson, Lillian Mahoney, Tim Seaman and Jim Skelly.
- 2. The minutes from February 2011 were approved with corrections.
- Treasurer Lolitia Bache gave the Treasurer's Report for 2010. There is still the
 ongoing problem with the youth accounting. A motion was made that there will be
 no paid out expenses until there is an acceptable accounting from the 2010 youth.
 The motion was seconded and passed.
- 4. Tonie Campbell reported that the Financial Inquiry Task Force is in the process of being formed regarding youth team issues.
- 5. LDR Report: Paul Greer reported that the schedule for the Dirt Dog Cross-Country Series has been set. The first meet is in late August at Guajome Park. There will be seven races plus the final. - 7. Nick Bernal gave a presentation on a street pole vault competition to be held at the Otay Ranch Town Center on May 29. He would like help with the promotion, sponsorship and locking in the athlete participation. A motion was made to give \$500 for the competition. The motion was seconded and passed.
- 8. Racewalk: Tim Seaman was introduced as the new Racewalking Chairman. He reported that there will be a racewalking competition on May 1 at UCSD.
- 9. Youth Chairman Michael Adkins reported by email that he his working with the youth teams to get their flyers and results to the webmaster. More background checks are being completed for the coaches but many assistant coaches haven't completed the process. The problem is being addressed at the youth meetings. Officials and volunteers are needed for the Association and Regional JO Championships held in June. A Hy-Tec disc needs to be ordered for 2011.
